MINUTES

Present: Vice Chairman Ladon Calhoun, Commissioner Nixon, Commissioner Cox, Commissioner Edwards

Vice Chairman Calhoun calls the meeting to order. Regular session 10/09/2023. A word of prayer from Commissioner Cox and Pledge of Allegiance followed.

HOUSEKEEPING:

Vice Chairman Calhoun stated first thing we need to do is approve the agenda, Is there any additions or questions. Commissioner Nixon made motion, Commissioner Cox seconded. All in favor. Motion carried.

Vice Chairman Calhoun stated approval of minutes. Did everyone get a chance to look them over, any additions or corrections. Commissioner Edwards made motion to approve, Commissioner Cox seconded. All in favor. Motion carried.

FINANCIALS

Vice Chairman Calhoun stated approval of finance financial reports. Any questions? Commissioner Cox made the motion to approve. Commissioner Edwards seconded. All in favor. Motion carried.

APPEARANCES

Pickleball – Leigh Ribolzi, Russ Henely and April Powell

Vice Chairman Calhoun asked the group if they want to talk. Ms. Ribolzi stated thank you all very much for having us some may not know who I am but quickly Leigh Ribolzi with family connection there's one of us in every county in the state we're state funded and our main focus in Miller County is health related and literacy and that comes out through our Shape Up Miller. One of our many Focus has been pickleball, I just want to thank you all as a county for being proactive and thinking outside the box and bringing using your assets which is our tennis courts and actually creating pickle ball out of this. We have gotten so many calls text messages from strangers that they've seen it online and asking can we come play and that's even out of County because their County and their City they do not have a pickle ball court so we have a wonderful assets I first want

to thank you all very much for taking that chance and doing that addition out there. So, with that being said we started in the summer Doug asked hey let's try to push this I'll help I'll order whatever you all need so thank you all for ordering the supplies to do that it was very easy to introduce people to the sport with the equipment it's hard to come out and it's scary to come out and then when you have to actually pay for something to do that no one really wants to do that so we actually was able to eliminate those barriers we make it very easy to come out we make it very convenient we tried it over the summer when churches weren't meeting on Wednesdays we had a very small group of seven that first came out and every single week it grew and grew we have had up to 36 coming out on a Thursday. I certainly could not do that without this team right here every single one of them has been so wonderful and helping. But those 36 we have had like 20 consistently coming all the time not only have they used our paddles but they've gone out and purchased their own and I will tell you even like \$120 paddles I would say that some of them are purchasing and no one's going to go purchase that unless they're serious and they're going to come back or at least I wouldn't. But so that's really cool families are coming out, it's not just one or two they're bringing their entire family and I don't know I mean do you all realize how rapidly like this sport is growing like crazy it's all over commercials are everywhere about it.

Ms. Powell stated professional pickle ball. Ms. Ribolzi stated I mean it's crazy it's in schools it's in high schools and middle schools. So I'm just so proud that you all are embracing this and allowing us to introduce this to the community and I am so serious about this that we actually wrote a grant purchased equipment and I've already got the superintendent of the school to approve it and so the PE department is going to introduce this with our youth because we've had such great interest with our youth out there on Thursdays and because our numbers are so high on Thursday we're now going to open it up for Tuesdays we say we started at 6 o'clock and people are already out here at 4:30 right TT on Thursday because they're worried they're not going to get enough courts they're already coming before our time is actually supposed to be started we've been able to keep up with really good data every single week we take pictures we send it to post it on social media we have sign in sheets everybody that's actually set foot out there including their children have signed the release of liability we appreciate the extra equipment and we already have people asking when can we have a league and when can we have a tournament one other thing I want to tell you and then I want you to talk about the tournaments and the leagues and but diversity this has been a really cool experience to see all ages anyone from a six-year-old which was one of mine there were several all the way to a 79 year old out there playing and coming back and like my 79 year old that I'm talking about she came and observed twice watched on the side had her rules and regulations asked questions and was out there ready to play last week so it was funny let's see I talked about elementary all the way to seniors the abilities we've got children with disabilities out there which I thought was amazing how much fun that they had and we when I met with our superintendent we have the cafeteria at the BOE, he has allowed us to open that up and have an indoor court so for our alternative kids alternative school kids and our special needs when they come over for art they can actually play right there indoor in the cafeteria we take that we have a portable net in there as well so if we grow this community wide and then we start growing youth to love it and play it's only going to grow even larger here locally plus all the out of County people that are wanting to come and participate in our stuff Just some families I was really proud of Sangria Branch brought her daughters out I was so happy to see all three of them play Rick and Becky LaGardia their entire family even their daughter-in-law is pregnant she's out there place and I love that she didn't

even let that stop. Daniel and Stacy Mock and their two kids I mean it's just wonderful Scott and Lori Tennant with all of their kids it was great to have old former tennis players. Ms. Powell stated yeah some of my tennis players came out and they I mean they loved it. Ms. Ribolzi stated they're back out there right now nothing organized they're out there with their own equipment. Tracy and Stephanie Odom I mean they're out there with their two boys who are now grownups but it's just really cool that they get to do that together as a family but we've been hitting work sites and so they're getting groups of people to come from the banks and Birdsong and just groups of friends a bunch of the girls come and they play so that's really all I just kind of wanted to give you some facts and data and showing you all how much it grows you all want to see I've got a book to prove it and you have any questions for me. Vice Chairman Calhoun asked is she going to talk about the tournament and stuff.

Ms. Powell stated I am, get a paddle out and a ball okay you can get a \$20 paddle that's about a \$20 paddle. This paddle is about 150 I mean however dedicated you are you can decide what you want this is the ball that they use it's just like an it's kind of like a Whipple ball and there's different balls for indoor and outdoor play like the indoor balls have bigger holes and the outdoor ones are a little bit smaller but okay y'all have a copy of the flyer good my name is April Powell I am a teacher here at the high school I'm a special education coach teacher and I coach girls and boys tennis I of course I play tennis and I started playing pickle ball probably a couple years ago and then Leigh approached me and she was like she was like I want you to play, come play pickle ball come play pickleball we need some help and I was like okay I'll come and so I started coming out there and you know helping and the whole month of September we did a free pickle ball Clinic like pickle ball 101 where you know they learned how to play and like I say we had 36 I mean I pulled up last Thursday night and this parking lot down here was full of cars I was like what in the world are they playing baseball or something down there I mean what's going on and it was all pickle ball players and I was just like floored I couldn't believe it but everybody's loving it and having fun and get some exercise but let me talk to you about the tournaments I've they act like I'm a professional or something but I played in three tournaments but the tournament that we want to have in November y'all all have a flyer of that let me talk about a tournament that I went to this past weekend it was a tournament in Moultrie and it was dinks for dinners it was to help with the like the Meals on Wheels program there were 62 players registered and it was \$55 a person to play so basically they brought in \$3,410 in registration fees our tournament we've done the cost a you know a little bit up I mean this is kind of like we're kind of got of getting our feet wet you know and trying to figure this thing out so we put it at \$30 and the max at 40 so I mean that's going to that's going to bring in about \$2,400 if we have 60 people at \$40 so I mean pickle ball it's all about getting people out and exercising and having fun but also it can be a source of a little bit of revenue to help run the rec department which is good and um the tournament can even be run by you can hire a tournament director or you can have your Rec director do it you know it's up to you and you know on your form you'll see that there are different levels like it starts out at a 2 0 a 2 0 is just a beginner I mean it's somebody that just started playing and then you go up to like a 4 5 and a 5 0 and those are you're really good like they play tournaments all the time they're good these two right here now the these guys would be like a three player like a three player I play in the I play in the well I play in like the three league so and also I kind of looked up online what different rec departments like charge if a group like from out of County just wanted to come and rent your courts they usually rent for about \$36 an hour you know if they wanted to just rent a court to play like in Dothan if I want to go play pickle ball it's three \$3.50 for court

fee to play each person it's 5.50 in Tallahassee I think it is yeah and they recommend like a \$12 for leagues like if we ran a league that maybe lasted a month you know it' be \$12 a person and you know also you want to keep cost low to keep people playing I mean you know you don't want to charge a astronomical amount. Ms. Ribolzi stated we want them to keep coming back to be healthier and active and it's good socialization and Russ may even want to talk about the health side of it. Mr. Henely stated well I do want to say something as y'all know I'm a veterinarian here I own the animal hospital my employees are the most sanitary people in this whole county I promise you for years I've been trying them to get them involved with bicycle riding I've even offered to help them buy bicycles, softball basketball volleyball you name it I begged them to do stuff, can't get anybody. There's something about this sport that three of them have already started and another two have promised that they're coming, I'm like what is it about this sport, once people hear about it or see it or whatever they want to play and once they play and do you want to mention about the golden Olympics.

Ms. Ribolzi stated yes because we have access to the courts we've added that as our new event every year we add a new event for our seniors Golden Olympics and it'll be pickleball this year so we look forward to utilizing the courts. Mr. Henely stated and at the state level or the national level if you get there. Ms. Ribolzi stated and I know do y'all have any questions so far for them. Commissioner Edwards asked if the fundings will go towards. Ms. Ribolzi stated so for this particular tournament this is our guinea pig to kind of see what how it will work the funding will be for our golden Olympics for our locals to go towards our seniors and then but you know we can host more of those and that could be a rec Department you know revenue so ours is going to be the guinea pig I guess to kind of see how well it does so. Ms. Powell stated and what we're proposing is to do either the top courts or the bottom courts it doesn't matter to me to making those one of those exclusive pickle ball courts and that would mean six courts so that would mean painting six pickle ball courts on the two tennis courts and then the two other tennis courts we would leave alone and you know that would be used for tennis the question is you know I coach High School tennis and I know the Middle School tennis team they use these courts for their practice and their play and I don't want to take that away from I mean it's y'all's decision if you want to you know keep at tennis and we'll just draw the pickle ball lines we can do that or if you want to if you want to make them strictly pickle ball and then keep the two top courts you know tennis.

Vice Chairman Calhoun stated so once we convert those courts they you can't convert them like you couldn't the kids couldn't come after school play tennis on them they would just be pickle ball forever. Commissioner Cox stated I'm sure the lines will probably mess them up. Ms. Powell stated yeah there are a lot of lines when you go to drawing the courts on there the way they are now is there are two pickle there's a pickle ball court on each tennis court and I play tennis on the courts that has happened and the pickle ball line and the serve line are real close to each other and it's hard to distinguish in your mind what's in and out so when you start drawing lines because as the high school tennis coach we could not play any region play on these courts because there's extra lines on there. Mr. Cofty stated what about the middle school is that the same with them. Ms. Powell stated no they can play they can play on the courts with the pickle ball lines they can still play on those courts. Ms. Ribolzi stated and we also want you to know that tennis season is one month right maybe practice. Ms. Powell stated for the middle school they practice a month and they play a month like four or five matches. Ms. Ribolzi stated and you're looking at less than 20 kids you know and over a whole year time you know you all just need to decide on what you all think would

be most important for the community you know. Vice Chairman Calhoun stated and the school system has tennis courts. Ms. Powell stated we do we have we have actually have six new courts but there are no lights hopefully we'll be getting lights I hope so but you know they usually do their practicing and play their season on these courts and you know the city of Colquitt has you know let us use these courts for like 20 years before the new courts were built at high school we appreciate that I mean you know free of charge they just let us use them so I'm not pushing one way or the other because certainly I don't want to you know take away tennis from the middle schoolers but you know we do have courts at the school but the middle school and the high school will have to share them. Commissioner Edwards asked when do the middle school practice they practice at night also. Ms. Powell stated they do, they do right after school they usually practice from like 4:00 to 5:30. Commissioner Cox stated that is still day they wouldn't need lights. Vice Chairman Calhoun stated if I remember it's been a long time but in school when the time changes they have tennis match sometimes they have to cut lights on to finish the match.

Ms. Powell stated you do before the time changes yes the first of the season I do all my beginning matches away at courts that have lights and then the end of my season I do them home because we have a little more daylight. Commissioner Edwards stated my concern would be taken away from them putting all the lines they won't be able to practice that would be my concern until you do get lights at the school I mean if the lights were at the school then it wouldn't be an issue but for now my main concern was taking away from them at this point. Commissioner Cox asked what kind of time frame do you think we have lights at the school or are they in the works of get them. Ms. Powell stated no I mean they're wiring for the capacity to get them but I mean it took 20 years to get tennis courts. Vice Chairman Calhoun stated longer than that, about 100. Ms. Ribolzi stated but have you gone have you actually been on the tennis court actually see the pickle ball and the tennis kind of looked at because it is I mean as a tennis player to me would be really hard and then as a pickleball player it's hard I would say for both. Commissioner Nixon stated so I went I looked and that was another concern of my like with because I do want to try to play um I the confusion of the lines that I mean I would be how much would it cost to renovate the courts like y'all are talking about here. Mr. Cofty stated we've got the paint we've got the paint left over 2 55-gallon drums now I don't know if it's enough they're sitting up under no it's full they're sitting up under that tree I don't know I don't know this good it's under a tree so we've got the paint. Vice Chairman Calhoun asked so what about the nets and stuff do you have to dig up the old nets. Mr. Cofty stated just painting. Ms. Powell stated no, what the nets that do now is do you show them these pictures Leigh, where the nets are now you would have three pickle ball courts on one side and that net would be a barrier to keep the balls from going to the other three.

Ms. Ribolzi stated this is the tennis net as it stands right now so that would be kind of like a barrier in Cairo, we actually went to observe and they used a fence here it was a chain link fence um so we've looked at trying to do other options because believe me we want to be able to make it work for everyone but currently the way it is right now there's only two pickle ball on each court because they were painted on top of the tennis courts so um here you all can take this if you want so I just I don't know and this is another option I guess y'all can keep both sorry um we have the paint we even were willing to paint it ourselves. Ms. Powell stated if we left two courts alone and I mean they could they could play in practice on those two courts it wouldn't you know leave them out the with no tennis courts and plus I mean I don't think you want to I wouldn't

convert both of them to a pickle ball to be honest with you I mean I would leave in case somebody wants to I mean there's people playing tennis right now some of actually some of my players I don't know why they're at the school not at the school playing but. Vice Chairman Calhoun stated I was told the school wouldn't let them be there after school hours what I've been told I've been told I don't know if that's true board somebody call in if they want to. Vice Chairman Calhoun stated so how much would it cost for extra nets and I mean we got paint. Ms. Powell stated Doug has already ordered them, they are portable. Vice Chairman Calhoun stated so you don't have to drill into the concrete. Ms. Powell stated they're nice I mean the best. Doug was really nice like I sent him I sent him what we need and like they were ordered the next day I was like wow. Mr. Cofty stated they were ordered under the rec department. Vice Chairman Calhoun stated did she say did she say it going to be eight courts or six. Ms. Ribolzi stated no, well it could be like it's just really how we angle it how we had measured before it would be. Ms. Powell stated well it would be six and then we would have the two that are the tennis courts now.

Mr. Cofty asked would you rather do them two up there those lights are the best. Ms. Powell stated I would rather. Vice Chairman Calhoun stated would you do it like this or not you would not do it like this. Commissioner Nixon stated so if we did it like this we could have eight pickleball courts. Ms. Ribolzi stated we could have to eight pickleball, we would have to measure everything and make sure. Commissioner Edwards stated we wouldn't have any tennis courts. Vice Chairman Calhoun stated we would still have two tennis courts, you would actually have. Commissioner Nixon stated well we wouldn't have this. Vice Chairman Calhoun stated it' be close if you did it if you tried to put eight down there is what I'm saying. Ms. Powell stated yeah we measured it out actually TT went down there and we measured it out and it would put them really close together. Vice Chairman Calhoun stated so you going to put six in those two courts down there and then you'll have some room on the side three on one side three on the other Commissioner Edwards stated and we'll have two regular tennis courts as we are not taking away from the kids. Ms. Ribolzi stated please know that kids are playing as well 6 and up it's crazy how the children are playing. Mr. Cofty asked if they more migrating to pickleball when younger now or tennis, what have you seen. Ms. Powell stated well now as far as schools are concerned I mean there's no pickle ball programs. Mr. Cofty stated if there was which one do you think they would go to tennis or pickle ball, would it be a hard choice. Ms. Powell stated I don't know. Ms. Ribolzi stated but once we introduce this once we introduce this into the schools and they have fun doing this at PE I can only see even more coming out to play. Mr. Henely stated and the seniors you can't get them to play tennis unless you hold a gun to their head and they will play pickleball.

Ms. Powell stated and I'm a tennis player and I play a lot in Bainbridge and people really aren't playing tennis anymore. Commissioner Nixon stated and Bainbridge is a pretty big tennis or used to be a pretty big tennis community you know. Ms. Powell stated I can go to I can go and play Pickleball every night in Bainbridge I mean they say open Play is only three nights a week they're there every night yeah and Bainbridge actually they've just built 12 covered courts. Mr. Cofty asked isn't the YMCA building them too. Ms. Powell stated I've heard they are but nothing's been going forward with that yet. Do you all have any more questions for us. Ms. Ribolzi stated sorry we took so long, just let us know. Vice Chairman Calhoun stated we will discuss it and we will let you all know something. Ms. Ribolzi stated okay and we'll see you guys out on Thursday is that the plan tomorrow. Vice Chairman Calhoun stated it's going to be raining Thursday all right

Ms. Ribolzi stated well there you go we have tomorrow got two days. Commissioner Cox stated thank you all for coming. Commissioner Edwards along with the rest of the board thanked them as well.

OLD BUSINESS

Fueling Center Report

Vice Chairman Calhoun stated next on old business is fuel center report. Mr. Cofty stated it's basically trucking along. We have not had any problems, we actually did I take that back we had a problem with one of the fuel cut offs on the DEF side of it where it's got a magnet on the end and if the magnet's not on it's not going to run well one of the school buses now own the magnet it's in one of their DEF tanks right so we've got replacements and it's up there working again that's the only issue we've had. I haven't noticed if there's been a backlog of vehicles lately. Mr. Moore stated every now and then you get three or four school buses but it's not been a problem for us. Mr. Cofty stated I've got PSG drawing up a quote just in case we need to add an additional dispenser we are up to I think the last one was \$15,000 gallons which is if you see the totals the money on the next page it's going up it's hovering around 50,000 a month which is good, that's all we have on the fuel center.

UTV Ordinance

Vice Chairman Calhoun stated we're going move on to the UTV registration ordinance Mr. Cofty stated so all I did on this one, Mr. Allen had said if any of you all had any questions to get with me. I haven't heard anything about it from any of you all so if you all are good I'll just start for this over to the attorney and have him go get it ready to be legalized and voted on.

NEW BUSINESS

Golf Course equipment financing

Vice Chairman Calhoun stated new business is the golf equipment financing. This is the just for the approval I think right. Mr. Cofty stated yes this you all did that in the group, we all decided to go with First State because they were the cheapest and they're working on the paperwork we just need to do a formal vote on that. Vice Chairman Calhoun asked you just need a motion in a second. Mr. Cofty stated yes. Commissioner Cox made the motion, Commissioner Nixon seconded. All in favor. Motion carried.

Department Job Descriptions:

Vice Chairman Calhoun stated next is Department Job Descriptions. Mr. Cofty stated this was what one of things the attorney and I had talked about redoing the policy procedures and then coming up with job descriptions which we've never had so I just included all you all and gave you a copy of what we what we came up with that's pretty much every department that we managed so you all just look it over and I'll get it to him and next will be the performance evaluations that'll be the next that'll be the last thing we have to do to get up to date. Commissioner Edwards asked does all the Departments have their job prescription every position already have it yeah well I gave I gave the ones this morning we had a department head meeting so I gave it to all the department heads what theirs were. Commissioner Edwards stated okay. Vice Chairman Calhoun asked Jennifer Jackson you got anything you want to. Ms. Jackson stated I'm just listening. Vice Chairman Calhoun stated you're just listening okay. Ms.

Jackson stated I'm assuming he's not talking about Constitutional Officers. The entire board as well as Mr. Cofty stated No, just the county, just the county employees. Ms. Jackson asked if we wanted to use those we could. Mr. Cofty stated I've got them created but we just put in place was for the county so I mean if you say hey I want to look at them then ok. But because as a county we have to have them whether you all accept them or not but if you all want them or if the Sheriff wants them I got them. Ms. Jackson stated okay. Vice Chairman Calhoun asked do you all want to go to executive session. Vice Chairman Calhoun stated anything else Doug that's it. Mr. Cofty stated that's it yeah on that one. Vice Chairman Calhoun stated and then the last is Departments

Departments

Mr. Cofty stated if you if you look at departments each department head is now started sending, the ones that can, the rec hasn't but the 911, the EMS and Road department all have sent their reports to look at. Vice Chairman Calhoun stated that like a lot of calls. Vice Chairman Calhoun stated is that a lot of calls that seems like a lot of calls is that normal is that a normal month. Commissioner Edwards stated 842. Vice Chairman Calhoun stated that's a lot, it seemed like a lot didn't it. Mr. Cofty stated 842 just for Miller and 318 for Baker. Vice Chairman Calhoun stated yeah I mean that's 1126 for the month of September there's 30 days in a month. Mr. Cofty stated that's pretty much all all right anything else anybody, I think we need a motion to adjourn. Commissioner Cox stated I did have a complaint out there on the Griffin Sheffield on that pipe, have you all completed out there. Mr. Moore stated no we hadn't got it completed now we put some in you know what I'm saying and we are working on that but you know we kind of battling peanut pickers and you know we are trying not to slow trying not to slow some of that day I mean right now just kind of hit us at a big time now we finished Brian Road but of what was the complaint. Commissioner Cox stated I guess it's not in the flow line, it's sticking up and they said it was settling. Mr. Moore stated I looked at it today because I went out moved the excavator and when you look down Kelly Road I mean it's ground level now it does one side is lower, you know Kelly side's lower than the Mount Olive side but I didn't notice I mean this it kind of look straight through the PIP it's ground level you know on one side ground level on the other side. Commissioner Cox stated so what about Miss Carolyn I went and looked at the one by Miss Carol Worsley's I don't we going to have to do something about it it's too high I know it's not the flow line the outlet I mean excuse me the inlet it's above the ditch line we're going to have to lower it.

Commissioner Edwards stated sort of like the one that right there at Kelly Road isn't it the one there's a hump. Mr. Moore stated oh now we going to build that up some too you know as we work. Both Commissioner Cox and Edwards stated but you are going to lower the pipe. Mr. Moore stated well I wasn't talking about lowering that one that one I didn't I didn't do that one out there be honest because I. Commissioner Cox stated we're going to have to lower it because it's actually got dirt in the flowline then the pipes on top of the dirt on top. Mr. Moore stated I was really trying to use it as an equalizer Jeff I wasn't trying to get it to go I was trying to let that side fill up because I don't go anywhere you know it fills up both ditches and what I was doing there was kind of letting it fill up you know hold some in both ditches because when it fills up it runs over and runs down a yard goes to her carport and that water is not flowing anywhere it's just a crossover pip there. Commissioner Cox stated but it's not going to be able to flow how it is now is what I'm saying the actual Inlet on that pipe is taller than the ditch line the flow line. Commissioner Cox stated what it's going to do that water's going to hit it

and it's going to start swirling and eat it out. Mr. Moore stated on the back side Mr. Moore stated I'll go look at it and see me we put it in on kind of an angle right there to keep it because it's coming down that road you know and wanted it to catch in instead of going you know where it would feed into it a little bit but be honest I hadn't seen it since they put it in because I had to go to the doctor to get it done. Commissioner Cox stated you might want to take a look at it because it's and I don't think they covered it up the end of it as well. I know on Griffin Sheffield, they didn't it's exposed so I mean. Commissioner Edwards agreed. Mr. Moore stated well we still got a lot of work to do there at Griffin Sheffield and that's all going to come up right there because it floods if it you know it don't I just had got to build but I didn't notice it being a rise today and I saw you know that's the only time I've seen the one at Griffin Sheffield because when I come down the road I was kind of you know the ditch line I was looking down the ditch you know and it went it went the way the water come it go straight through the pipe from the Mount Olive side but I'll look at it closer but like I said I had hadn't seen either one of them because when I come back we've been chasing peanut pickers you know I really hadn't had time to go work on neither one of them we've been cutting limbs that's pretty much all we've done for two weeks. Commissioner Cox stated I think your pipe is going to be taller than the flow line. Mr. Moore stated I got you. Commissioner Cox stated you just need to lower it. All in favor. Motion carried.
